Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and checking account information
- Account transactions and account balances
- Payment history and credit history

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Nelnet chooses to share; and whether you can limit this sharing.

They can be financial and nonfinancial companies. Our affiliates include companies with a Nelnet name; financial **Affiliates** companies, such as those holding and/or servicing loans; nonfinancial companies, such as those providing educational services to schools and students; and others, such as holding companies. Companies not related by common ownership or control. They can be financial and nonfinancial companies. **Nonaffiliates** Nonaffiliates we share with can include companies providing education planning and finance products and services, direct marketing companies, financial institutions, and government entities. A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Joint marketing Our joint marketing partners include companies providing education planning and finance products and services, direct marketing companies, financial institutions, and government entities.

Other important information

Vermont residents - In accordance with Vermont law, we will not share information we collect about Vermont residents with nonaffiliates except as permitted by law, such as with the consent of the customer or to service the customer's accounts. **California residents** - In accordance with California law, we will not share information we collect about California residents with nonaffiliates except as permitted by law, such as with the consent of the customer or to service the customer's accounts. We will also limit the sharing of information about you with our affiliates to the extent required by applicable California law.
